

## DEXUS STANDARD COMPETITION TERMS & CONDITIONS

### Beenleigh Marketplace / 'Find the Golden Ticket' campaign 2019 Terms and Conditions

1. These terms and conditions are for all entrants who enter the 'Find the Golden Ticket' Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Wholesale Property Limited (ABN: 47 006 036 442) as Trustee for Dexus Wholesale Retail Trust (ABN: 50 358 792 115). Beenleigh Marketplace 114-118 George Street, Beenleigh, QLD 4207.

#### ELIGIBILITY

3. Subject to condition 3, this Promotion is only open to Australian residents aged 18 years or over.
4.
