

DEXUS STANDARD COMPETITION TERMS & CONDITIONS

Beenleigh Marketplace / "Free gift for Mum" - Mother's Day 2021
Terms and Conditions

1. These terms and conditions are for all entrants who enter the 'Free gift for Mum' Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Wholesale Property Limited (ABN: 47 006 036 442) as Trustee for Dexus Wholesale Retail Trust (ABN:50 358 792 115).

The address is Beenleigh Marketplace 114-118 George Street, Beenleigh, QLD 4207.

ELIGIBILITY

3. Subject to conditions, this Promotion is only open to Australian residents aged 16 years or over.
4. The following are ineligible: (i) employees of the Promoter, Dexus or any of the tenants or retailers in the Participating Centre/s or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

5. This Promotion commences at 10:00am Australian Eastern Standard Time ("AEST") on Saturday 1st May 2021 and ends at 1:00pm on Saturday 8th May 2021 AEST (excluding Monday 3rd May 2021) or when the prizes have been exhausted ("Promotion Period").

HOW TO ENTER

6. To enter this Promotion, eligible individuals must, during the Promotion Period, simply:
 - Make a purchase of \$10 or more at any participating retailer
 - Present proof of their purchase by presenting a receipt of \$10 or more spent at a participating retailer to the Beenleigh Marketplace Gift Station
 - Participants will immediately choose and receive one prize subject to availability
7. It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoters database and to be used in accordance with the purposes set out in these Terms and Conditions.

LIMITS ON ENTRY

8. Participants are entitled to one prize per person, per day.

ENTRY DETAILS

9. Receipts from lay-by products, payments of bills or accounts and receipts from the purchase of gift vouchers, tobacco products, alcohol products and lottery products are excluded and cannot be used to claim a prize under this promotion.
10. Each receipt will be validated. All receipts must be clearly identified as being from a participating retailer. Each receipt must be dated within the promotional period and a prize (subject to availability) can only be claimed on the same day that a valid retail purchase has been made in accordance with these terms and conditions.
11. The redemption of the prize will take place at the Gift Station Desk at Beenleigh Marketplace, 114-118 George Street, Beenleigh QLD 4207 located at the top of the Centre's travelators. The Gift Station Desk during the promotional period is open Saturday 1 May 2021 – Saturday 8 May 2021 (excluding Monday 3 May 2021) from 10am – 1pm. The Promoter reserves the right to request winners to provide proof of identity and/or proof of entry validity in order to claim a prize.

GENERAL

The Promoter reserves the right, at any time, to verify the validity of entries (including contacting Participating Retailers) and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If this Promotion is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion to the fullest extent permitted by law to (a) disqualify an entrant; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.
26. The Promoter's decision is final, and no correspondence will be entered into.
27. Any cost associated with accessing the promotional website is the entrant's responsibility and is dependent on the Internet service provider used. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including their respective officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter; (d) any variation in the prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by an entrant or winner; or (f) use of the prize.

PRIVACY
